1. Open Public Hearing - Proposed 2025 Budget

a. Confirmation of Publication of Notice of Public Hearing

Chief Sackett confirmed that a notice of this Public Hearing had been properly published in the Post Independent on September 27, 2024, and in the Citizen Telegram on September 26, 2024. It was also displayed at the administration office and on the District's website at www.crfr.us.

b. Review of Proposed 2025 Budget

Chief Sackett reviewed the proposed 2025 budget with the Board, highlighting a significant reduction in assessed valuation, leading to a 26.7% revenue drop (approximately \$3.5 million). Chief Sackett stated that the conservative budget being presented is designed to maintain stability for the department. Chief staff would like to give personnel a 1-3% Cost of Living Adjustment (COLA) if funding is available. The Board and Chief Sacket discussed aspects of the proposed 2025 Budget, including the importance of having qualified mechanics for fire apparatus and the need for a comprehensive understanding of associated costs and market competitiveness in staffing.
